Donation Stations collect fresh food and funds from farmers' market customers in order to buy food at farmers' markets for local agencies feeding the food insecure. This year Donation Stations collected 36,000 lbs and collected/spent \$18,000 at local markets. We served 32 agencies, reaching over 20,000 individuals.

POP Market (Pennies on the pound) - Connects agencies serving food insecure community members with local food at an affordable price. This year we bought from 31 farmers, sold to 16 buyers, specifically nonprofits and social mission driven businesses, and returned \$35,000 in sales to local farmers.

Other Programs include "Farm to Children", which works with afterschool snack and weekend backpack programs to supply nutritious locally grown fresh food to children at risk for hunger (supplemented buying power for institutions feeding children, providing fresh food to over 2500 children regularly); "Farm to Family", which provides predictable amounts of fresh local food to families who are at risk for hunger or malnutrition and who cannot easily access food pantries (provided food from 11 farmers to 18 families in 2 counties); "Food Ambassadors", which provides fresh food education (developed educational materials).
