POP Market (Pennies on the pound) - Connects agencies serving food insecure community members with local food at an affordable price. We bought from 31 farmers, sold to 16 buyers, specifically nonprofits and social mission driven businesses, and returned \$36,215 in sales to local farmers.

Donation Stations collect fresh food and funds from farmers' market customers in order to buy food at farmers' markets for local agencies feeding the food insecure. This short year Donation Stations collected 20,000 lbs and collected/spent \$16,892 at local markets. We served 35 agencies, reaching over 20,000 individuals.
