**Our Wholesale Market offers small and mid-scale North Carolina farmers a means of selling what they grow and advice on pricing, marketing, and safe food-handling practices. Our goal is to help hard-working farm families (especially beginning farmers, female farmers and farmers of color) make a decent living while providing nutritious, local food to schools and universities, local agencies and institutions, and grocery stores and other businesses. In 2017 alone, our Wholesale Market provided \$454,000 worth of produce to North Carolina residents.**

**We also operate Donation Stations at 38 farmers markets, where volunteers use funds contributed by shoppers to purchase food from farmers, supporting their livelihoods. Farmers help too by donating unsold produce, reducing waste. This food is given to local hunger relief agencies and other organizations supporting vulnerable children and adults. In 2017 alone, our Donation Stations amassed nearly 68,000 pounds of food for 55 local agencies and spent \$42,000 with local farmers, helping them to make a living.**

**Through our Community Foodshare project, neighborhoods and community partners serving low-income, food insecure families form a produce-buying club to promote greater food security. The project provides ready access to fresh, locally grown food and nutrition education. Each Community Foodshare project is structured with input from participants to ensure that it utilizes the community's assets and addresses its unique needs.**
